SALB OPERATIONS DURING COVID-19 LOCKDOWN RESTRICTIONS

Due to Covid-19 lockdown restrictions, the Library is currently not fully operational. This is because we are not listed as an essential service provider in the Regulations to the Disaster Management Act. Certain staff are back on duty to fulfill Compliance reporting to National Treasury and the Department of Sports, Arts and Culture and preparation work for the annual audit. Under the guidance of senior management, the staff are testing out a combination of work from home and a rotational shift work schedule from the office to minimize potential exposure to the Corona Virus. Despite SALB not considered to be an essential service according to current Government Regulations, we are aware of the importance of providing reading material in alternative formats and staff are working actively behind the scenes in this respect. We are aware of the inconveniences caused by the lockdown but SALB stands in solidarity with the measures imposed by the President to curb the spread of the COVID-19 pandemic.

SALB MINI LIBRARY UPDATE

All Mini Libraries remain closed and all our mini library members will be informed in due course on the opening of public libraries as directed by Government. SALB continues to engage provinces on the readiness to reopen in due time once the lockdown levels are lowered and it is safe to do so.

UPDATE ON CIRCULATION OF LIBRARY MATERIAL

Due to the national level 4 lockdown restrictions currently in place, the library is unable to circulate or receive any library materials until further notice.

SALB WEBSITE UPDATE

The newly designed website is almost complete and is currently in its testing phase. Compliance testing was done via the daisy consortium accessibility testing platform and using the services of Vision Australia during the design phase. SALB Management and some pilot members were requested to test the website for their accessibility and user experience and to date positive results have been obtained. The website boasts new features such as streaming and downloading of books online, as well as a refreshed member experience for reserving and loaning of books. Current members will also be able to update their details online as well as new potential members being able to register online as well. The website is set to be launched by end of June 2020, should no unexpected delays occur.
