Section 1: Financials

Income

The income received for the period is R5.5 million. The income was derived from the following sources

Subsidy (Government):	R 4,572,000
Donations and Bequests:	R 169,000
Interest from Investments:	R 296,000
Project Income and Other:	R 463,000

The funding receipts from the National Department of Arts and Culture are consistent with the allocation letter received from the Department. Interest Income from Investments are in line with projections. Project Income has been received in advance and is matched as expenditure is being incurred.

Expenditure

The major expenses incurred for the period are listed below:

Salaries:	R 3,938,000
Travel and Subsistence	R 172,000
Recruitment fees:	R 118,000
Project Expenditure	R 785,000

The expenditure per programme is in line with the budget.



Balance Sheet

Cash and Cash equivalents is R26.7 million.

Trade and other receivables R0.3 million.

Accumulated Surplus R18.6 million

Government Grants R5.0 million.

Trade and other payables R1.7 million.

Provision for Post-Retirement Benefits R3.5 million

Performance over the period

Revenue of R5.5 million including projects was generated and expenses of R5.8 million was incurred which resulted in a net loss of 0.3 million for the period; however, is on track for the year. The Financial Position of the Library is in a healthy position as indicated by the cash reserves of R26.7 million.
